16. Castlewood Dress Code:

Client / Tournament Coordinators are responsible for informing all their participants about Castlewood Country Club's Dress Code.

-Dress Code for Men: Must wear a collared shirt, slacks or shorts, and shoes. Shirts must remain tucked in at all times. Non-metal spike golf shoes are required on the golf course and practice areas. Headwear must be worn bill-forward. **Not permitted:** Jeans or denim of any type, cargo shorts/pants, athletic shorts, shorts with an inseam less than five (5) inches, t-shirts, tank tops, fishnet shirts, shirts without sleeves or without collars.

-Dress Code for Women: Must wear a skirt, slacks or Bermuda-length shorts. Tops must have a minimum of a 3 inch shoulder. Non-metal spike golf shoes are required on the golf course and practice areas. Headwear must be worn bill-forward **Not permitted:** Jeans or denim of any type, cargo shorts/pants, athletic shorts, shorts with an inseam less than five (5) inches, t-shirts, tank tops, halter tops.

Persons wearing improper attire will unfortunately not be allowed to remain on club premises unless improper attire is changed.
